

End-User License Agreement (EULA)

If you register for a free trial of the software, this EULA agreement will also govern that trial. By clicking "accept" or installing and/or using the software, you confirm your acceptance of the Software and agree to be bound by the terms of this EULA agreement.

If you are entering into this EULA agreement on behalf of a company or other legal entity, you represent and warrant that you have the authority to bind such entity and its affiliates to these terms and conditions. - Client may not sell, rent, lease, or sublicense the Software. Licenses can be used by the licensing organization and its group companies in accordance with the licensed number of users;
- Reproduce, copy, distribute, resell or otherwise use the Software for any commercial purpose;
- Allow any third party to use the Software on behalf of or for the benefit of any third party,

- use the Software for any purpose that PTM EDV Systeme GmbH considers a breach of this EULA agreement,
